Select a provider for Category 4 training

• Recurrent Training (Category 4) – Only for individuals who already hold the type rating for which training will be sought. The type rating must appear on their FAA certificate or foreign airman certificate accepted by the FAA

Name must be EXACTLY as shown on your documents, Passport & Visa



Upload CLEAR images of your documents (passport, visa, & any licenses if required)



Training Dates can be estimated: exact dates are not required



The equipment selected on your application must match the "scheduled" training from Pan Am Flight Academy

You have now completed your application for CAT 4.

Once the request has been submitted, please allow 72 hours for Pan Am to validate the request. Students will then receive an email advising the request has been validated. Instructions on how to proceed with the application will also be included.

After validation from PAN AM is completed, TSA will send an email advising "Provider Accepted" and request any additional information or requirements if needed.

You will then receive periodic updates from TSA advising of status updates as they become available.
